Colonia Escondida Home Owners Association Pools Rules and Regulations The Pool area include the two pools and the enclosed fenced area around the pools.

Rules

- 1. NO LIFEGUARD ON DUTY. ALL PERSONS USING THE POOL DO SO AT THEIR OWN RISK!
- 2. All household members and their guests are required to sign the sign-in sheet. Guests may be asked for proof of age. If you do not sign in, you may be asked to leave the pool area.
- 3. Children under 15 years of age are absolutely prohibited from pools area without parent or adult (18 yrs. or older) supervision. Children ages 15 to 17 are not allowed to supervise children under the age of 15.

- 4. The pool gate must not be propped open or otherwise rendered inoperable, even temporarily.
- 5. No glass containers, alcoholic beverages, tobacco products, illegal substances, or pets are permitted in the pool area.
- 6. Food must be kept at least four feet from the pool. (This is a NM State Regulation).
- 7. Diving into the pools is not permitted.
- 8. To protect pool equipment, APPROPRIATE SWIM WEAR IS REQUIRED!!!! The following are NOT permitted: Balloons, Cotton T-Shirts, Cut-off Shorts, Cutoff Shirts, non-toilet trained children without plastic pants over diapers or swimming diapers.
- 9. Pool furniture is not to be used in or put into the water.
- 10. To make the pools safer & clean for everyone, please shower to rinse off suntan oils and/or perspiration prior to using the pools.
- 11. No swimming permitted during lightning storms. Leave pool and seek immediate cover in the event of a lightning storm. Safety equipment is to be used only in case of an emergency.
- 12. No littering. Use trash receptacles provided. Resident shall be responsible for paying clean-up expenses, repair costs and damages caused by resident and/or resident's guests and children.
- 13. Anyone causing a disturbance will be required to leave pools area. Disturbances include, but are not limited to: Running, boisterous play, foul language, inappropriate music and music volume.
- 14. The wading pool is intended for babies and toddlers. <u>Constant adult supervision is required</u>. No running or splashing in the wading pool area.
- 15. Any resident renting the clubhouse for a private party does not have exclusivity to the pool. Residents may still have access to the pool during your event.
- 16. Board members may come up and enforce these rules. If you are not in compliance, you will be asked to leave, and you may be banned for a time. Any appeals to these rules or punishment may be made to the Board of Directors at a regularly scheduled meeting (6:30, second Monday of each month).

The pools may be closed for the following reasons:

Operational and mechanical difficulties affecting pool water quality.

During severe weather conditions (heavy rain, lightning, and thunder and warnings), especially when visibility to the pool bottom is compromised (deck also is closed for 30 minutes following the last occurrence of thunder or lightning.

For a period of time following any mishap that results in feces or vomit in the pool.
