Dues are \$31.65 a month and payable to Colonia Escondida % Dana Properties P O Box 105007 Atlanta GA 30348-5007

As per HOA Bylaws, HOA dues are billed on an annual basis. You may continue to make monthly, quarterly or annual payments. Any accounts or fines past due are subject to the HOA delinquent policy and may incur a 6% per annum interest penalty and loss of privileges for not more than 60 days.

Payment of monthly dues is a requirement in a mandatory HOA. If you do not receive a monthly statement this <u>does not</u> absolve you of this commitment.

YOUR HOA DOES MAINTAIN SOME RECORDS REGARDING PAST OWED DEBTS OR PAYMENT PLANS. IF YOU ARE IN ARREARS, CONTACT THE HOA TO RESOLVE ANY ISSUES.
