HOA Dues & Fees

Dues are \$31.65 a month and payable to Colonia Escondida % Dana Properties P O Box 105007 Atlanta GA 30348-5007

As per HOA Bylaws, HOA dues are billed on an annual basis. You may continue to make monthly, quarterly or annual payments. Any accounts or fines past due are subject to the HOA delinquent policy and incur a 6% per annum interest penalty and loss of privileges for not more than 60 days.

Payment of monthly dues is a requirement in a mandatory HOA.

Businesses Operated from Homes

Did you know it is violation of our Association Bylaws and city codes to operate a business from any home. AirBNB Businesses are also prohibited in our neighborhood. Code Enforcement may issue a citation for this type of activity. Your HOA also has the discretion of issuing fines ranging up to \$500 monthly for operating a business from a home in Colonia Escondida.
