

## Public Meeting Regarding Proposed Subdivision



There is a public meeting on the Proposed Subdivision on Girl Scout Rd, January 14, 2026 at 5:30 pm at city of Sunland Park chambers on McNutt. The developer is resurrecting permits to rezone the two parcels to build 100 homes. Neighborhood residents are strongly urged to attend this meeting and voice their opinions regarding these plans.

## Changes to the Monthly Assessment Fee

The monthly assessment fee is now \$32.60 a month. In accordance with Association Bylaws the assessment fee may be adjusted annually. There was no increase in fees from 2017 until 2025. This resulted in your HOA attempting to manage 2026 expenses with 2018 revenue.
